- \* Prospects are slim of the Festival returning due to high cost of police involvement and the road work costs
- \* Policing costs- concerns were raised that the DD festival is the only festival activity in the area of Yass Valley to have such a large number of police involved. It was reported that this is due to the isolation of WJ. Motion moved by Charlie Barton sec Jean-luc Foulon "That the community write letters to Police Minister, Local Member, and cc to Yass Valley Council, expressing their support for the Dragon Dreaming Festival and the financial benefit to the wider community of Yass. The concern of the community is that this could be jeopardised by the extremely high expense of policing. The community indicated that increased expense due to isolation of the community is discriminatory." Motion passed Jenny asked Charlie Barton and John Robinson to compose these letters.
- \* Charlie Barton requested that money be transferred into the Fire Brigade account. This discussion was directed to the 'February Minutes' which stated that a letter from each organisation be presented to the association saying how the money will be used.

## Local Facility- John Parker

There was a meeting with John Parker and other community members and 2 yass valley councillors. Council are investigating and a reply not expected until into the new year. Mel Cook is investigating the crown land aspect and Geoff Frost commented that there is discussion in council of crown land maybe being handed to councils.

Helen Cathles raised the need to think about other fund raising activities and bring suggestions to the next meeting.

### YASS VALLEY COUNCIL NEWS

Geoff Frost thanked everyone for voting for him and he was pleased to be in the position. New appointments - Rob Fish Director of Engineering, Sharon Hutch- Director of Finances Roads- pleased to have disaster funding for local roads, notify council of any concerns that are not being addressed.

Community Halls- suggestion of a change in arrangements for managing local halls. There will be more documentation and consultation.

Swimming Pools- raised the awareness of the great cost of running swimming pools. It cost council \$180,000 to run the pool last year and income was \$125,000. A heated pool costs to maintain are extremely high. Council not keen to carry this cost.

Yass Valley Council Consultation Meetings- 24th November in Yass, 29th November in Binalong Crown Land - discussions taking place

### **GENERAL BUSINESS:**

<u>School Presentation/ Community Christmas party-</u> Moved Janet Smith, Sec John Parker That the association pay the \$350 for the jute box. Secretary to write to Principal accepting this cost. <u>School Camp</u> - School writing asking that the association pay \$4652 from the Dragon Dreaming money . Motion moved by Charlie Barton, Sec John Robinson "that \$3000 be allocated to the school" This motion was passed.

Some members of the association expressed concern re the amount of money the P&C is holding in its account and that should the school close this money would be lost. The association asked the secretary to write to the school expressing this concern

## **Fund Raising**

Chris Garner said she had ideas of raising money for the association. Chris stated that if others would like to join her in organising some activities it would be much appreciated and that those who volunteered need to be willing to put in the work. A group of people volunteered and Chris is organising a meeting.

# **School Numbers**

Geoff Kell raised the issues of the school and the small number of students attending the school and that this is not due to students being available to attend but rather that the educational needs of the students are not being met.

Bridgette shared that she had written to the department and state government re her concerns. The parent body and Pru Goward had met as well as a meeting with the departments representative.

Concerned was also expressed that the image of the school in the Yass area was being damaged and casuals would not come to work at the school.

Moved Geoff Kell, sec Jean-Luc Foulon "That a letter of concern be written by the association and the ramification of the school closing was not due to the lack of available numbers but that the parents had lack of confidence in the Teaching Principal. The association needed to express the importance of the school to the community." This motion was passed and the association agreed that the letter be written by Janet Smith.
